OTP Bank Plc. announces that – according to the Resolution No. 8/2024 of the Annual General Meeting on 26 April 2024, as a part of implementing the Bank’s remuneration policy – OTP Bank Employee Stock Ownership Plan Organization (ESOP Organization) transferred 3,061 shares to OTP Bank Plc. on 2 January 2025, based on the Remuneration Policy of ESOP Organization.

Due to the transaction the stock of own shares owned by the OTP Group has been changed to 7,052,884 shares. The stock of own shares is altogether 2.52%.
